- 24.111 No members of the public were in attendance. 24.112 Council resolved to receive apologies from Cllr. Perkins and County Cllr. S. Williams. 24.113 No member's declaration of interest to items on the agenda. 24.114 Council resolved to approve the minutes for 11th November 2024. 24.115 Report was received from District Councillor Turner-Wilkes. This will be published on the website. The report focuses in particular on Government devolution proposals. SDC are progressing with a new local plan. Cllr Ractliffe observed that Harescombe do not appear to have been considered for planning locations as part of the local plan. There are only large houses and no affordable housing for young locals. Clir. Turner-Wilkes will make enquiries of SDC and report back to Cllr. Ractliffe and the clerk. 24.116 Report received from County Councillor, circulated and published on the website. Finance. 24,117 Council noted that Mrs I. Litton has agreed to act as the council's competent and independent internal auditor. 24.118 Council noted the annual CIL report for 2023/2024 has been submitted to SDC and has been published on the parish council website. The parish council has submitted a nil return of CIL expenditure. 24,119 Council resolved to authorise a payment of £235.00 for hall hire for meetings. 24.120 Following approval of a budget at the last meeting, for a replacement the Harescombe sign following unreported damage, the sign has been repaired by a parishioner. Council resolved not to replace the sign, and to take no further action at this time.

- Vehicle Passing Places The clerk received no communications regarding Pound-of-Candles Lane passing place. Cllr. Ractliffe received 7 messages of support for improvements, although the cost was a concern to some respondents. Council resolved that the clerk should contact GCC Highways Manager and County Councillor Williams to consider progressing this matter. Furthermore, both should be asked to consider what maximum support could be offered towards costs. Clerk to research the legality of financing the work if the layby would be within Haresfield Parish boundary.
- Village road surfaces Forty-four more road surface deficiencies have been identified on Gruntas Lane and Pound of Candles Lane. The clerk will need to report each deficiency individually through FixMyStreet. County Councillor was been contacted to see what she can do to push for resurfacing. Highways will check to see where, if at all, these 2 roads sit on the list for resurfacing.

Cllr Ractliffe expressed concern about a drain in Church Lane and asked if Highways could note this for when resurfacing works take place. Cllr. Ractliffe to pass the location to the clerk.

- Fingerposts at Edge Church update. Signs have been received and are at the clerk's home address for safekeeping. They will be installed by Highways once their Community Projects Team is reformed in April.
- 24.135 Overgrown verges from the triangle to the Harescombe sign Council resolved that as the hedges and verges are under the ownership and control of local farmers, the council will not pursue this matter. NFA
- 24.136 Haresfield Lane, newly cut drainage ditches Council noted that Haresfield Parish Council have confirmed that the main drainage ditches in areas along Haresfield Lane were recently recut by Highways to alleviate highway flooding issues. Additionally, local farmers maintain their roadside hedges and ditches where they feel they have become unsafe.
- 24.137 **Gruntas Lane / Blue-Bell Lane Grit Bin** Highways have agreed to a request from the clerk for a bin at this location. However, no blue new blue bins are available until next financial year. Council resolved to accept Highways offer of a bin at this location to be installed for next winter.
- 24.138 **Edge Resurfacing** Council noted that Highways have committed to recutting existing drainage 'grips' once the resurfacing has been completed.
- 24.139 Matters arising (no decisions can be made on such matters).
  - Councillors to keep an eye on a local location regarding potential planning issues. Cllr T-W to discuss with County Councillor.
  - Council considered physical protection of the layby next to the Haresfield sign and decided not to proceed at this time.
  - Possible relocation of the Harescombe Village sign to be considered at the next meeting.
